

#### ace program outcomes

A total of 111 VIP clients participated in ACE. Engaging classes and activities provided enhanced career exploration, job preparation, and social skills trainings for each participant.

Two family meetings were held at VIP. In April, IRC discussed Person Centered Planning and, in December, Advocacy 101 was presented by CDSA. More than 154 family units attended the meetings.

Over 92 Person Centered Planning meetings were provided at VIP locations. Meetings were conducted to discover and plan what is important to each client and focus on goals for the future.





