# highlights and more!

- VIP switched its payroll and time and attendance system to Paylocity.
   This allowed for increased compliance with regulations while being a more efficient platform for staff.
- ClearCo., a talent management software, was implemented and significantly decreased the average cost per hire. The system created a workflow and filtration system for recruitment and an electronic orientation and onboarding packet.
- Talent engagement remained at the forefront with the implementation of the STAR Employee of the Quarter Award and The VIP SCOOP, a quarterly staff newsletter. In addition, staff contests and incentives were offered throughout the year.
- We officially started our ACE/055 program. ACE, with a small staff-to-client ratio, provides a variety of opportunities for access to the local community as well as training opportunities that are geared toward independence and employment.
- VIP invested in additional staff to support our sales efforts, for both individual and group placements, throughout the Inland Empire.

## race to ACE where the sky's the limit!

VIP is proud to announce the kickoff of ACE, our newest and most innovative program! The ACE/055 Program commenced in Rancho Cucamonga in May 2023 and in San Bernardino in July 2023 (the Hesperia ACE Program is slated to begin services in March 2024).

The ACE Program, offering a small staff-to-client ratio, provides a variety of opportunities for access to the local community as well as training opportunities that are geared toward independence and potential employment. Trainings may include, but are not limited to: development of work rules and vocational talents; social and life skills; health and wellness; and advocacy. ACE trainings are comprised of creative and engaging activities including volunteerism, job exploration, educational classes, community tours, A-TEAM meetings, and other valuable resources. Community access and integration are a critical part of ACE.

Rancho Cucamonga ACE had 17 clients enter the program while San Bernardino ACE had six clients enrolled. VIP developed new partnerships and rewarding volunteer opportunities with the following organizations:

- Community Action Partnership in Montclair, Highland, and San Bernardino
- Helping Hands in San Bernardino
- Laurel Wellness Care Center in Fontana
- SCIL Center in Claremont
- Foothill Family Shelter in Upland

ACE focuses on creative and innovative activities that encourage and spark new ideas, passions, and goals. Our past ACE activities include trainings and tours to gain knowledge on a wide variety of topics including:

- · nutrition, food preparation, and clean cooking
- health and wellness, including yoga and meditation
- warehouse and equipment safety
- the supply chain process including packaging of product, quality control, and distribution of goods
- the creativity and collaboration involved in producing an animated TV show
- professional attire and appearance as well as appropriate cues for the workplace
- therapy dog certification process
- behind-the-scenes operations of successful businesses, including a baseball stadium and a resort hotel

ACE is an opportunity to learn, grow, invent, and reinvent. We have set substantial goals for 2024 and are continually increasing engagement while improving processes. VIP's Direct Service Advisors, DSAs, are the backbone of the program as they conduct daily research to ensure that each activity is fun, captivating, and meaningful — their creativity and collaboration are inspiring! 
